The Merger Agreement is on file with the Securities and Exchange Commission as an exhibit to the Current Report on Form 8-K, as amended, filed by Hewlett-Packard Company on September 4, 2001, and is incorporated by reference into this filing.

HP STATEMENT IN RESPONSE TO RETIREE BENEFITS CHANGES AND THE COMPAQ MERGER

Hewlett-Packard retirees and employees are asking: "Has HP agreed to change retiree health benefits in the Compaq merger?" The answer to the question is: No. Coverage under any HP benefit plan is determined by the terms of the plan in question and not by the terms of the merger agreement. HP has not in any way agreed to change HP retiree health benefits in connection with the Compaq merger.

Many of the inquiries have focused on a statement in the HP-Compaq merger agreement, which was reprinted in the HP-Compaq joint proxy, indicating that HP provides no retiree medical benefits. The statement was a standard, legal boilerplate that is common in merger agreements.

The short answer is, the HP retiree medical benefits program will continue for current retirees after the merger.

The language in the merger agreement may be confusing, but it's a necessary legal requirement, says Susan Bowick, HP vice president of Human Resources.

"When we have changed benefits programs in the past," Susan says, "we've thoroughly developed alternatives, agreed on the end goal and guiding principles, and communicated decisions well ahead of implementing them, once they have been made.

"This is how we will continue to handle any decisions around all HR programs going forward. Nobody will have to read about anything in the fine print of a proxy statement. That's not how we do business at HP."
