This statement is filed pursuant to Rule 13d-2(b) with respect to the Common Stock, \$1.00 par value par value (the "Common Stock") of Champion Enterprises, Inc. (the "Issuer") beneficially owned by the Reporting Persons specified herein as of December 31, 2008 and amends and supplements the Schedule 13G filed by the Reporting Persons on April 10, 2008 (collectively, the "Schedule 13G"). Except as set forth herein, the Schedule 13G is unmodified.

The names of the persons filing this statement on Schedule 13G are: MAK Capital One L.L.C., a Delaware limited liability company ("MAK Capital"), MAK Capital Fund LP, a Bermuda limited partnership ("MAK Fund"), Michael A. Kaufman ("Mr. Kaufman"), Paloma International L.P., a Delaware limited partnership ("Paloma"), and S. Donald Sussman ("Mr. Sussman," and collectively, the "Reporting Persons").

The Reporting Persons collectively beneficially own 3,467,357 shares of Common Stock, consisting of: (i) 2,108,753 shares of Common Stock and (ii) notes issued by the Issuer ("Notes") convertible into 1,358,604 shares of Common Stock.

The Reporting Persons have beneficial ownership of 3,467,357 shares of Common Stock constituting 4.4% of all of the outstanding shares of Common Stock.
