- (1) Mr. Hovde, a director of Great Wolf Resorts, Inc. (the "Company"), was granted 7,684 shares of common stock of the Company (the "Shares"), in lieu of receiving directors fees in cash payable to the reporting person for service on the Company's board of directors during the second quarter of 2009. The Company calculated the number of shares granted using a closing price per share value of \$2.43, on April 1, 2009. The Shares vested immediately upon their issuance.
 - (2) As of the date hereof, including the transaction reported herein, Steven D. Hovde ("SDH") is the beneficial owner (within the meaning of Section 16 of the Securities Exchange Act of 1934, as amended) of 149,708 Shares. The beneficial ownership of these Shares is more fully set out in the following footnote 3.
 - (3) SDH owns 121,568 Shares directly; SDH is the trustee to The Hovde Financial, Inc. Profit Sharing Plan and Trust, which owns 8,825 Shares; and SDH is the trustee to The Eric D. and Steven D. Hovde Foundation, which owns 19,315 Shares.
