(a) The Annual Meeting of Heritage Financial Corporation (the “Company”) was held on May 2, 2018.

(b) There were a total of 34,013,413 of the Company’s common stock outstanding and entitled to vote at the Annual Meeting. At the Annual Meeting, 30,354,891 shares of common stock were represented in person or by proxy, therefore a quorum was present. The following proposals were submitted by the Board of Directors to a vote of shareholders:

Proposal 1. Election of Directors. The following individuals were elected as directors for one year terms:
