## **Merger Agreement**

On August 3, 2007, NATIONAL HEALTHCARE CORPORATION (<u>NHC</u>) entered into Amendment No. 2 (the <u>Amendment</u>) to the Agreement and Plan of Merger by and among DAVIS ACQUISITION SUB LLC, a Delaware limited liability company (<u>NHC/OP Sub</u>), NHC/OP, L.P., a Delaware limited partnership and the direct parent of NHC/OP Sub (<u>NHC/OP</u>), NHC and NATIONAL HEALTH REALTY INC., a Maryland corporation (<u>NHR</u>) dated as of December 20, 2006 (the <u>Merger Agreement</u>).
