- (1) This Registration Statement shall also cover any additional shares of Avocent Corporation common stock that become issuable under the 2003 Inducement Plan and the OSA Technologies, Inc. 2000 Stock Plan (the "OSA Stock Plan") by reason of any stock dividend, stock split, recapitalization or other similar transaction effected without the Registrant's receipt of consideration which results in an increase in the number of the outstanding shares of Registrant's common stock.
- (2) On April 6, 2004, the Registrant completed the acquisition of OSA Technologies Inc., a Delaware corporation. In connection with the acquisition, the Registrant assumed the OSA Stock Plan and all options outstanding and available for issuance thereunder and is obligated to issue up to 238,351 shares of common stock of the Registrant pursuant to the exercise of stock options that were outstanding under the OSA Stock Plan on the date the acquisition was consummated.
- (3) Calculated solely for purposes of this offering under Rule 457(h) of the Securities Act of 1933, as amended, (the "Securities Act") on the basis of the average of the high and low prices of the Registrant's Common Stock as reported on the Nasdaq Stock Market on April 8, 2004.

The Registrant hereby amends this Registration Statement on such date or dates as may be necessary to delay its effective date until the Registrant shall file a further amendment which specifically states that this Registration Statement shall thereafter become effective in accordance with Section 8(a) of the Securities Act of 1933 or until the Registration Statement shall become effective on such date as the Commission, acting pursuant to said Section 8(a), may determine.
