Item 1. Security and Issuer.

This statement relates to the common stock, \$.001 par value (the “Common Stock”) of ARCA biopharma, Inc. (the “Issuer”) having its principal executive office at 11080 Circle Point Road, Suite 140, Westminster, CO 80020.

On June 10, 2015, GEO entered into a Securities Purchase Agreement among the Issuer, GEO and certain other purchasers (the "Purchase Agreement"), a form of which is attached as Exhibit 10.1 to the Issuer's Form 8-K filed on June 11, 2015 (the "8-K") and incorporated by reference herein, pursuant to which GEO acquired 10,221,465 shares (the "GEO Shares") of Common Stock and a certain Warrant to Purchase Common Stock, a form of which is attached as Exhibit 4.1 to the 8-K and incorporated by reference herein, subject to certain limitations, up to an aggregate of 4,088,586 shares of Common Stock (the "GEO Warrant Shares" and, together with the GEO Shares, the "Securities"), exercisable immediately, from the Issuer, at a purchase price of \$0.8805 per unit, in a private placement transaction (the "Offering") for an aggregate purchase price to GEO of \$8,999,999.93
