**ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT**

On November 9, 2012, Appiphany Technologies Holdings Corp., a Nevada corporation (the Company) entered into a Consulting Agreement (the Consulting Agreement) with Brian D. Jones ( Mr. Jones ), pursuant to which Brian D. Jones shall provide services to the Company as a business consultant, in regards to the Company's ongoing development and marketing of its technology, for a period of three (3) months, renewable at the option of the parties. In exchange for his services, the Company shall issue a total of eight hundred thousand (800,000) unrestricted shares of the Company's common stock, valued at \$0.01 per share, from the Company 2012 Equity Incentive Plan registered on Form S-8.
