This prospectus supplement amends and supplements the prospectus dated April 3, 2015, as previously supplemented (the "Prospectus"), which forms a part of our Post-Effective Amendment No. 5 to Registration Statement to Form S-3 on Form S-1 (Registration Statement No. 333-166556) that was declared effective on April 3, 2015. The Prospectus relates to the sale and issuance of up to 3,057,500 shares of common stock of Jones Soda Co. to holders of outstanding warrants, upon exercise of such warrants.
