#### **Explanatory Note**

Pursuant to Rule 13d-2(a) of the General Rules and Regulations under the Securities Exchange Act of 1934, as amended, the undersigned hereby amends the following items on Amendment No. 3 to the Schedule 13D originally filed by the Reporting Persons on November 19, 2008, as amended on April 30, 2009 and July 10, 2009.

#### Item 4. <u>Purpose of Transaction</u>.

On December 16, 2009, Avenue AIV US, L.P. (Avenue AIV) exercised, through a cashless exercise (i) warrant dated October 9, 2008 granted by the Issuer to Avenue AIV for 30,000,000 shares; (ii) warrant dated April 8, 2009 granted by the Issuer to Avenue AIV for 7,500,000 shares; and (iii) warrant dated July 2, 2009 granted by the Issuer to Avenue AIV for 7,500,000 shares.

The shares of Common Stock underlying such warrants are entitled to certain registration rights as evidenced by the Registration Rights Agreement as disclosed in the Issuer s Current Report on Form 8-K filed with the Securities and Exchange Commission on October 14, 2008 and the Registration Rights Agreement Acknowledgement, dated as of July 2, 2009 (filed as Exhibit 10 to the Reporting Persons Amendment No. 2 to Schedule 13D filed with the Securities and Exchange Commission on July 10, 2009).

The Reporting Persons intend to review their investment in the Issuer on a continuing basis. Depending on various factors including, without limitation, the Issuer s business prospects, other developments concerning the Issuer, general economic conditions and stock market conditions, and any other facts and circumstances which may become known to the Reporting Persons, the Reporting Persons may in the future take such actions with respect to their investment in the Issuer as they deem appropriate.

Except as described herein, the Reporting Persons do not as of the date of this Statement have any specific plans or proposals that relate to or would result in any of the transactions described in subparagraphs (a) through (j) of Item 4 of Schedule 13D.

As previously disclosed, pursuant to a Designated Director Agreement entered into between NextWave Wireless, Inc. (the Issuer) and Avenue Capital Management II (the Director Agreement), at any time when one or more members of the Avenue Capital Group, or their affiliates hold (individually or collectively) a majority of the outstanding principal amount of the Senior Subordinated Secured Second Lien Notes due 2010, Avenue Capital Management II shall have the right, in consultation with the Issuer's Governance Committee to nominate a director to the Board of Directors of the Issuer (the Board) as soon as the Board has a vacancy or at any election of directors by the Issuer's shareholders when there is not currently an Avenue Capital Management II designated director serving on the Board.

Carl Vogel was nominated by Avenue Capital Management II pursuant to the Director Agreement and has been elected to the Board to fill a vacancy. Mr. Vogel is not affiliated with Avenue Capital Management II and is not receiving any compensation from Avenue Capital Management II in connection with his service on the Board. Mr. Robert Symington, an employee of Avenue Capital Management II also

currently serves on the Board of the Issuer.
