Item 2.02 Results of Operations and Financial Condition.

On May 6, 2014, Primoris Services Corporation, a Delaware corporation (Primoris , the Company) issued a press release announcing its financial performance for the first quarter ended March 31, 2014.

Item 5.07 Submission of Matters to a Vote of Security Holders.

The annual meeting of the stockholders of Primoris, was held on May 2, 2014. The total number of shares of the Company s common stock issued, outstanding and entitled to vote at the meeting was 51,655,224 shares. Represented at the meeting either in person or by proxy were 46,243,259 shares, or 89.5% of shares entitled to vote. The results of the votes for the proposals were as follows:

To elect one Class C director to hold office for a three-year term expiring at the annual meeting of stockholders to be held in 2017 or until their respective successors are elected and qualified.

To ratify the appointment of Moss Adams, LLP as our independent registered public accounting firm for the fiscal year ending December 31, 2014.

- Votes Against 198,643
- Votes Abstain 71,775
