The Schedule 13D filed with the Securities and Exchange Commission on December 11, 2000 (the Initial 13D) by CFW Partners, the Trust and Mr. Charles F. Willis, IV with respect to the Common Stock, par value \$0.01 per share (the Shares), issued by Willis Lease Finance Corporation, a Delaware corporation (the Issuer), as amended on August 28, 2013, September 26, 2013, July 1, 2015 and December 22, 2015 (together with the Initial 13D, the 13D), is hereby amended to reflect changes in the beneficial ownership information for each of the reporting persons that have occurred as a result of repurchases of Shares by the Issuer. Capitalized terms not defined herein have the meanings ascribed to them in the 13D.

Item 3. Source and Amount of Funds or Other Consideration

Item 3 of the 13D is hereby amended to add the following disclosure following the last paragraph of Item 3 of the 13D:

On February 3, 2016, Mr. Charles Willis returned previously restricted Shares to the Issuer to satisfy withholding tax liability.

On March 1, 2016, the Issuer awarded a restricted stock grant of 75,000 Shares to Mr. Charles Willis vesting over three years.

A total of 200,000 Shares were accepted by the Issuer for repurchase from M3 Partners, LP on March 21, 2016. The Issuer closed the repurchase on March 21, 2016. Due to the resulting decrease in the number of outstanding Shares, and the net number of Shares acquired by Mr. Charles Willis since the date of the last report, the percentage of Shares beneficially owned by the Reporting Persons changed by one percent (1%) or more from December 22, 2015, the date of the last transaction reported in the 13D.

Item 4. Purpose of the Transaction

Item 4 of the 13D is hereby amended to add the following disclosure following the last paragraph of Item 4 of the 13D:

February 3, 2016: The return of previously restricted Shares by Mr. Charles Willis to satisfy withholding tax liability.

March 1, 2016: The Issuer awarded a restricted stock grant of 75,000 Shares to Mr. Charles Willis vesting over three years.

March 21, 2016: Due to a decrease to the number of outstanding Shares due to a repurchase by the Issuer, and the net number of Shares acquired by Mr. Charles Willis since the date of the last report, the percentage of Shares beneficially owned by the Reporting Persons changed by one percent (1%) or more from December 22, 2015, the date of the last transaction reported in the 13D.

Item 5. Interest in Securities of the Issuer

As disclosed below, each of the Reporting Persons may be deemed to beneficially own (as that term is used in Rule 13d-3) the Shares held by the other Reporting Persons. Pursuant to Section 13d-4 of the Securities Act of 1933, as amended, each of the Reporting Persons disclaims beneficial ownership of all Shares held by each of the other Reporting Persons.

Items 5(a), 5(b) and 5(c) of the 13D are hereby deleted and replaced with the following:

(a) The Reporting Persons may be deemed to beneficially own (as that term is used in Rule 13d-3), in the aggregate, 3,005,389 Shares, representing approximately 40.48% of the Issuer's outstanding Shares (based upon the 7,624,891 Shares stated to be outstanding as of March 7, 2016 less the 200,000 Shares accepted by the Issuer for repurchase). Pursuant to Section 13d-4 of the Securities Act of 1933, as amended, each of the Reporting Persons disclaims beneficial ownership of all Shares held by each of the other Reporting Persons.

(b) For purposes of this statement, as of March 21, 2016:

- CFW Partners had shared voting power and shared dispositive power over the 2,134,148 Shares held by CFW Partners. Mr. Charles Willis had shared voting power over 2,134,148 of such Shares and shared dispositive power over the 2,134,148 Shares held by CFW Partners. Mr. Austin Willis had shared voting power over 405,488 of such Shares.
- Mr. Charles Willis had sole voting power over 771,019 Shares, including 6,338 Shares held in a custodial account in the name of Charles F. Willis, V, the son of Mr. Charles Willis, of which Mr. Charles Willis serves as the custodian. Mr. Charles Willis had sole dispositive power over 467,181 Shares. Mr. Charles Willis may also have been deemed to have had shared voting power and dispositive power with respect to 98,222 Shares held by Mr. Austin Willis.
- Mr. Austin Willis also had shared voting power and shared dispositive power over 98,222 Shares (pursuant to the Military Durable Power of Attorney dated August 24, 2012 and further discussed in Item 6 of the amendment to the 13D filed on August 28, 2013, Mr. Charles Willis has shared voting power and shared dispositive power with regard to the Shares held by Mr. Austin Willis with respect to the Shares held by Mr. Austin Willis and the 19% limited partnership interest in CFW Partners held by Mr. Austin Willis).
