The total also includes 4,655.16 Restricted Stock Units (RSUs) granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP), and

(2) reflects the acquisition of 47.54 RSUs on 4/15/10, 47.25 RSUs on 7/15/10, 44.30 RSUs on 10/15/10, and 44.30 RSUs on 1/18/11 pursuant to a dividend reinvestment feature of the LTIP. The phantom stock units and RSUs are automatically payable in shares of PG&E Corporation common stock only. This total also includes 4,062.92 shares held in the PG&E Corporation Dividend Reinvestment and Stock Purchase Plan (DRSPP), and reflects 144.31 shares of PG&E Corporation common stock acquired on 4/15/10, 143.56 shares on 7/15/10, 133.99 shares on 10/15/10, and 133.99 shares on 1/18/11 pursuant to a dividend reinvestment feature of the DRSPP.
