This Schedule 13D is being filed pursuant to Rule 13d-2(a) under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), on behalf of Silver Creek Capital Management LLC, a Washington limited liability company (the "Reporting Person"). The Reporting Person is the investment manager of certain private investment funds that own Common Shares of Flagstone Reinsurance Holdings Ltd, a Bermuda exempted company (the "Company" and such funds, the "Private Funds"). This Schedule 13D relates to the Common Shares, par value \$0.01 per share, of the

Company. Unless the context otherwise requires, references herein to the "Common Shares" are to such Common Shares of the Company. The Private Funds directly own the Common Shares to which this Schedule 13D relates, and the Reporting Person may be deemed to have beneficial ownership over such Common Shares by virtue of the authority granted to it to vote and to dispose of the securities held by the Private Funds including the Common Shares.

Item 1. Security and Issuer

This statement on Schedule 13D relates to the Common Shares of the Company and is being filed pursuant to Rules 13d-2(a) and under the Exchange Act. The address of the principal executive offices of the Company is 23 Church Street, Hamilton, HM 11, Bermuda.

Item 2. Identity and Background

- (a) This statement is filed by the Reporting Person. The Reporting Person is organized as a limited liability company under the laws of the State of Washington.
- (b) The address of the principal business and principal office of the Reporting Person is 1301 Fifth Avenue, 40th Floor, Seattle, Washington, 98101.
- (c) The principal business of the Reporting Person is to serve as investment manager or adviser to the Private Funds and other affiliated private investment funds, and to control the investing and trading in securities of such entities.
- (d) The Reporting Person has not, nor, to the best of its knowledge, any of its directors, executive officers, general partners or members has, during the last five years, been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).
- (e) The Reporting Person has not, nor, to the best of its knowledge, any of its directors, executive officers, general partners or members has, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.
- (f) The Reporting Person is a Washington limited liability company.

Item 3. Source and Amount of Funds or Other Consideration

A certain Private Fund received 943,397 shares of Common Shares of the Company in a distribution with respect to its investment in an unaffiliated private investment fund (the "Transaction"). The trade and settlement date of the Transaction is March 22, 2010.

Item 4. Purpose of Transaction

The purpose of the Transaction was to make a discretionary distribution to a certain Private Fund in connection with its investment in an unaffiliated private investment fund.

The Reporting Person may cause the Private Funds to make acquisitions of Common Shares from time to time or to further dispose of any or all of the Common Shares held by the Private Funds. The Private Funds may from time to time receive further Common Shares in connection with their respective investments in unaffiliated or affiliated private investment funds.

The Reporting Person is engaged in the investment business. In pursuing this business, the Reporting Person may analyze the operations, capital structure and markets of companies, including the Company, on a

continuous basis through analysis of documentation and discussions with knowledgeable industry and market observers and with representatives of such companies.

Except as set forth above, the Reporting Person does not have any present plans or proposals that relate to or would result in any of the actions required to be described in Item 4 of Schedule 13D. The Reporting Person may, at any time, review or reconsider its position with respect to the Company and formulate plans or proposals with respect to any of such matters.

Item 5. Interest in Securities of the Issuer

- (a) As of the date of this Schedule 13D, the Reporting Person beneficially owns 7,185,009 shares (the "Shares") of Common Shares. The Reporting Person has dispositive power over such holdings. The Shares represent 8.7% of the 82,985,219 shares of Common Shares outstanding as of February 22, 2010, as reported in the Company's Form 10-Q for the quarterly period ending December 31, 2009. The percentages used herein and in the rest of this statement are calculated based upon this number of outstanding shares.

None of the Private Funds own a number of shares of Common Shares representing more than 5% of the total outstanding shares of Common Shares.

- (b) The Reporting Person has dispositive power over the 7,185,009 shares of Common Shares held directly by the Private Funds.
- (c) Except as set forth below, during the last 60 days there were no transactions in the Common Stock effected by the Reporting Person, nor, to the best of its knowledge, any of their directors, executive officers, general partners or members.
