- (1) Mr. Hunt was awarded 33,589 Restricted Stock Units. Each Restricted Stock Unit represents a contingent right to receive one share of Repligen Corporation's Common Stock. The Restricted Stock Units vest in equal annual installments over a three-year period beginning on the first anniversary of the grant date. The Restricted Stock Units may be settled only by delivering shares of Repligen Corporation's Common Stock, and thus, the grant is being reported in Table 1 as allowed per SEC guidance.
 - (2) Payment of tax liability made via forfeiture of 2,267 shares of Common Stock valued at \$26.05 per share on February 29, 2015.
 - (3) The shares vest in equal annual installments over a three-year period beginning on the first anniversary of the grant date.
