Investment description

· Linked to the EURO STOXX 50[®] Index.

Unlike ordinary debt securities, the securities do not pay interest or repay a fixed amount of principal at maturity. Instead, the securities provide for a payment at maturity that may be greater than, equal to or less than the initial public offering price of the securities, depending on the performance of the Index from its Initial Index Level to its Final Index Level.

The payment at maturity will reflect the following terms:

o If the level of the Index increases:

You will receive the initial public offering price plus 200% participation in the upside performance of the Index, subject to a maximum total return at maturity of 91.00% of the initial public offering price

o If the level of the Index stays unchanged or decreases but the decrease is not more than 20%:

You will be repaid the initial public offering price

o If the level of the Index decreases by more than 20%:

You will receive less than the initial public offering price and will have 1-to-1 downside exposure to any decrease in the level of the Index in excess of 20%

· Investors may lose up to 80% of the initial public offering price

How the maturity payment amount is calculated

The maturity payment amount will be determined as follows:

· If the Final Index Level is greater than the Initial Index Level, the maturity payment amount per security will equal the lesser of:

(i) \$1,000 plus

(ii) the maximum maturity payment amount

· If the Final Index Level is equal to or less than the Initial Index Level but greater than or equal to the Buffer Level, the maturity payment amount per security will equal the issue price of \$1,000.00

· If the Final Index Level is less than the Buffer Level, the maturity payment amount per security will equal: \$1,000 -
