The Registrant expects to report a net loss of approximately \$12,872,000 for the fiscal year ended January 31, 2004, as compared to a net loss of \$2,825,700 for the prior fiscal year. Included in the expected net loss is approximately \$4.9 million attributable to change of control expenses and \$2.6 million attributable to a provision for merchandise which the Company intends to discontinue offering for sale in its stores. The Registrant expects to report an increase in Net Sales to approximately \$212,500,000 (as compared to \$201,513,897 for the prior fiscal year), as a result of an increase in wholesale sales, offset by a decrease in retail sales.
