As of December 31, 2008, Jack Silver beneficially owned 4,100,000 shares of Common Stock of HearUSA, Inc. representing 9.2% of the outstanding Common Stock based on 37,918,254 shares of Common Stock outstanding as reported in the issuer's Quarterly Report on Form 10-Q for the quarter ended September 27, 2008 plus 6,400,000 shares of Common Stock that were issued subsequently as reported in the issuer's Current Report on Form 8-K filed for the date December 23, 2008. Such shares of Common Stock beneficially owned by Mr. Silver include: (i) 800,000 shares of Common Stock held by Jack Silver; (ii) 300,000 shares of Common Stock issuable upon exercise of warrants held by Jack Silver; and (iii) 3,000,000 shares of Common Stock held by Sherleigh Associates Inc. Profit Sharing Plan, a trust of which Mr. Silver is the trustee.

Mr. Silver has the sole voting and dispositive power with respect to all 4,100,000 shares of Common Stock beneficially owned by him.
