- (1) 6,658,500 of these shares are held in a Grantor and Beneficiary, Revocable Trust
- (2) Reporting person and her husband, Thomas B. Hagen, are limited partners of the Hagen Family Limited Partnership which holds 10,092,900 Class A non-voting shares and 1 Class B voting share. Mr. Hagen is the only general partner of the partnership having sole voting power and investment power over the shares held by the partnership, and the reporting person disclaims beneficial ownership of those shares.

There is no expiration date for these securities.
- (7) Each share of Class B Common Stock is convertible at any time into 2,400 shares of Class A Common Stock. There are no exercise or expiration dates associated with this conversion feature and no specific exercise price when a Class B share is converted into Class A shares.
- (8) Pursuant to the Articles of Incorporation of the Company, as amended, shares of Class B Common Stock (voting) of Erie Indemnity Company are convertible at any time to shares of Class A Common Stock (non-voting) at a conversion rate of 2,400 shares of Class A Stock for each share of Class B Stock.
