("Common Units"); and (ii) options to purchase 28,000 shares of common stock. Also excludes the following securities indirectly beneficially owned by the reporting person: (i) 2,064,843.73 Common Units held by a Grantor Retained Annuity Trust (the "GRAT"); (ii) 50,000 Common Units held by the William & Phyllis Mack Foundation, Inc., a charitable foundation of which the reporting person is a trustee (the "Foundation"); and (iii) 833,769.02 Common Units held by other trusts (the "Trusts"). Pursuant to Rule 13d-4, the reporting person disclaims beneficial ownership of all securities held by the GRAT, the Foundation and the Trusts. The foregoing ownership amounts reflect the transfer of 156,577 Common Units from the GRAT to the reporting person on January 19, 2006, a transaction exempt from reporting under Rule 16a-13.
