(1) Mr. Stalder participated in a private placement of the Company's securities, which closed on October 11, 2006. Pursuant to the terms of the private placement, the securities were sold to each purchaser in units, at a purchase price of \$1.1325 per unit. Each unit consists of one share of common stock and one warrant to purchase shares of common stock in an amount equal to 50% of the shares of common stock sold to each purchaser.

(2) Includes the following warrants: 15,823 issued on 2/02/2004 at an exercise price of \$3.79; and 46,729 issued on 10/11/2006 at an exercise price of \$1.18.
