The performance criteria applicable to the 58,264 shares reported on November 18, 2011 were not achieved and, as a result, these shares did not vest. The vesting of the remaining awards is subject to the achievement of certain performance criteria and therefore not reportable on Form 4 until the time, if any, that such criteria are met.
