(1) Each restricted stock unit represents a contingent right to receive one share of Alere common stock.

The restricted stock units were awarded pursuant to a restricted stock unit agreement on August 31, 2014 and will vest as follows: 6,666 on the first anniversary of the grant date (8/31/15); 6,667 on the second anniversary of the grant date (8/31/16); and 6,667 on the third anniversary of the grant date (8/31/17).

(3) Vesting of shares under the Alere 2010 Stock Option and Incentive Plan was suspended from March 1, 2016 until two business days after Alere's SEC filings became current. Shares vested on September 9, 2016 represent shares that otherwise would have vested during the suspension period.
