- (4) Service Based Restricted Stock Award. These restricted shares will vest 100% on the fifth anniversary of the grant date.
Performance Based Restricted Stock Award. These restricted shares will vest based on performance on the third anniversary of the grant date. The performance measure has been defined as EPS growth measured as a three-year compound annual growth rate (CAGR) from December 31, 2006 - December 31, 2009.
