(a Delaware corporation), which is owned 50% by filer. Filer is an indirect beneficial owner of these reported securities.
 - (2) The convertible debenture is convertible into common stock of the Company at any time prior to the repayment date. It is payable upon the earlier of (i) July 31, 2010, (ii) six months after repayment of the senior facility, or (iii) upon certain changes of control.
