Of the 46,274 common shares beneficially owned by the reporting person 9,373 are Restricted Shares, which vest in four equal installments on the last day of each of the four fiscal quarters of service following their grant date and 26,901 are Restricted Shares, which vest in three equal installments on the last day of each the three fiscal quarters of service following their grant date.
