(1) In accordance with the Company's board compensation policies, Mr. Kumar received a grant of 247,832 RSUs, which were reported on January 6, 2012. The Company subsequently discovered that the Company's RSU plan limits annual grants to 200,000 RSUs per participant. Accordingly, the Company and Mr. Kumar agreed to reduce his grant to 200,000 RSUs, which grant will vest in four equal installments on March 27, 2012, June 26, 2012, September 25, 2012 and December 18, 2012.
