On 03/09/2011, the reporting person was granted an option to purchase 168,563 shares of Common Stock. The option vests based upon (1) time (five equal annual installments that began on 03/09/2012) and performance (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P. (collectively, the "Sponsors")) criteria.

(2) As a result of the sale of shares by the Sponsors on 08/15/2012, the performance criteria was met with respect to 66,560 shares of common stock subject to this option award, resulting in vesting of the option as to 13,326 shares and an additional 53,234 shares of common stock that are eligible to vest in four equal annual installments beginning on 03/09/2013. In total, following this event, the performance criteria has been met with respect to all of the shares of common stock subject to this option award, with 33,712 of such shares vested and the remaining 134,851 of such shares eligible to vest in four equal annual installments beginning on 03/09/2013.
