- (1) Restricted stock units awarded pursuant to the Markel Corporation 2012 Equity Incentive Compensation Plan. Subject to certain conditions, restricted stock units will vest on May 13, 2016.  
In addition to the award of 3,805 restricted stock units reported on this Form 4, the total includes 890 restricted stock units granted pursuant to the Markel Corporation 2012 Equity Incentive Compensation Plan and the Markel Corporation Omnibus Incentive Plan, as applicable, that will vest, subject to certain conditions, on December 31, 2017; 2,224 restricted stock units granted pursuant to the Markel Corporation Omnibus Incentive Plan that will vest, subject to certain conditions, on May 10, 2015; and 1,066 restricted stock units granted pursuant to the Markel Corporation Omnibus Incentive Plan, of which 347 units will vest on December 31, 2013 and 719 units will vest on December 31, 2015.
