- (1) On July 23, 2013, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 27,750 of the 111,000 Performance Shares granted to Mr. Pimentel on April 6, 2011. The 27,750 Ordinary Shares will vest on April 6, 2014 (or, in certain circumstances, at the opening of the next following trading window), subject to continuous service through such date.
- (2) On July 23, 2013, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 6,000 of the 24,000 Performance Share Units granted to Mr. Pimentel on September 10, 2012. The 6,000 Ordinary Shares will vest on September 10, 2013, subject to continuous service through such date.
