(1) The transactions reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on December 14, 2012.

The sale prices reported in column 4 of Table 1 represent the weighted average sale price of the shares sold ranging from \$98.07 to \$99.03 and \$99.09 to \$99.79, per share, respectively. Upon request by the Commission staff, the Issuer, or a security holder of the Issuer, the Reporting Person will provide full information regarding the number of shares sold at each separate price.

(2) This option is subject to an early exercise provision and is immediately exercisable. One ninety-sixth of the original shares subject to the option vested on January 30, 2006 and one ninety-sixth of the shares vest monthly thereafter.

(3) This option vests in forty-eight equal monthly installments beginning on September 15, 2009.

(4) This option vests in forty-eight equal monthly installments beginning on April 3, 2010.

(5) This option vests in forty-eight equal monthly installments beginning on April 3, 2011.

(6) This option vests in forty-eight equal monthly installments beginning on April 3, 2012.
