Unilever NV announces that on 29 February 2008 it purchased 1,250,000 Unilever NV ordinary shares (in the form of depository receipts thereof) at prices between euro 20.520 and euro 20.750 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 58,535 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 136,734,999 Unilever NV ordinary shares in treasury, and has 1,577,992,701 Unilever NV ordinary shares in issue (excluding treasury shares).
