QVT Financial is also the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account), which held 89,867 shares of Common Stock as of December 31, 2004. QVT Financial has the power to direct the vote and disposition of the Common Stock held by each of the Fund and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 418,000 shares of Common Stock, consisting of the shares owned by the Fund and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial.

As of December 31, 2004, the Fund beneficially owned 328,133 shares of Common Stock. QVT Associates GP LLC, as General Partner of the Fund, may be deemed to beneficially own the same number of shares of Common Stock reported by the Fund.

Each of QVT Financial and QVT Financial GP LLC disclaim beneficial ownership of the 328,133 shares of Common Stock owned by the Fund and the 89,867 shares of Common Stock held in the Separate Account.
