QVT Financial LP ( QVT Financial ) is the investment manager for QVT Fund LP, Quintessence Fund L.P., QVT Overseas Ltd., QVT Associates LP, QVT Global II L.P., Quintessence Global II L.P., Quintessence Associates LP and Quintessence Overseas L.P. (each, a Fund and collectively, the Funds ). The Funds beneficially own an aggregate amount of 1,741,358 shares of Common Stock. In addition, QVT Financial is the investment manager for a separate discretionary account managed for Deutsche Bank AG (the Separate Account ), which holds 352,163 shares of Common Stock. QVT Financial has the power to direct the vote and disposition of the Common Stock held by each Fund and the Separate Account. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 2,093,521 shares of Common Stock, consisting of the shares owned by the Funds and the shares held in the Separate Account.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial.

Each of QVT Financial and QVT Financial GP LLC disclaims beneficial ownership of the shares of Common Stock owned by the Funds and the shares held in the Separate Account.

The reported share amounts reflect amounts beneficially owned by the reporting persons as of September 10, 2007, as adjusted for subsequent transactions through the date hereof.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated based on 36,736,726 shares of Common Stock outstanding, which is the total number of shares issued and outstanding calculated based on information reported in the Issuer s Current Report on Form 6-K filed with the Securities and Exchange Commission on July 24, 2007.
