Attached is an English translation of the summary of the letter dated September 28, 2007 filed by the Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated September 28, 2007, the Company reported that on that date, holders of Company's Convertible Notes that had already exercised their conversion right exercised their warrant rights. Hence, a reduction of 29,267,367 warrants and an increase of 53,701,581 ordinary shares face value pesos 1 (V\$N 1) each was made. As a result, the amount of shares of the Company goes from 498,078,288 to 551,779,869. The new amount of warrants outstanding is 13,959,042. The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance. The amount of shares acquired is equal to the amount of shares into which it was converted the convertible note at a price of US\$ 0.6541 for each share face value pesos 1. Therefore US\$ 35,126,204.13 entered into the Company.
