(the Company) adopted technical amendments to the Company s Amended and Restated By-Laws to expressly authorize the issuance of uncertificated shares of capital stock. The Board of Directors adopted these amendments to comply with the New York Stock Exchange (the NYSE) requirement that securities listed on the NYSE be eligible for participation in the Direct Registration System by January 2008.
