This amendment amends the prospectus supplement dated January 8, 2008, relating to sales made in at-the-market transactions of shares of our common stock. During the three month period ended December 31, 2007, we sold an aggregate of 1,115,100 shares of our common stock in at-the-market transactions. Cantor Fitzgerald & Co. (Cantor) acted as placement agent with respect to the sales, pursuant to a Controlled Equity Offering Sales Agreement, dated June 29, 2007, between us and Cantor (the Sales Agreement), as described in the accompanying prospectus, as supplemented. The Sales Agreement has been filed as an exhibit to our Current Report on Form 8-K filed with the Securities and Exchange Commission on June 29, 2007 and is incorporated by reference herein. In connection with these sales, we paid commissions to Cantor as follows:

The information included in the Registration Statement on Form S-3, as amended (No. 333-143173), filed with the Securities and Exchange Commission on May 23, 2007, as amended or supplemented, is hereby incorporated by reference into this prospectus supplement.

Our common stock trades on the New York Stock Exchange under the symbol ANH. On January 9, 2008, the last reported sales price of our common stock was \$8.32 per share. Our Series A Preferred Stock trades on the New York Stock Exchange under the symbol ANH-PA. On January 9, 2008, the last reported sales price of our Series A Preferred Stock was \$23.30 per share. Our Series B Preferred Stock trades on the New York Stock Exchange under the symbol ANH-PB. On January 9, 2008, the last reported sales price of our Series B Preferred Stock was \$21.41 per share.
