This Registration Statement on Form S-8 is being filed for the purpose of registering an aggregate of 548,174 shares of the Registrant's common stock, par value \$0.01 per share, that may be issued upon vesting of restricted stock units granted under the Optichron, Inc. 2011 Restricted Stock Unit Plan, which the Registrant is assuming on April 5, 2011 pursuant to the Agreement and Plan of Merger dated March 20, 2011 by and among NetLogic Microsystems, Inc., Alinghi Merger Corporation, Optichron, Inc. and David Liddle, as representative of the stockholders of Optichron, Inc.
