On August 1, 2011, Market Leader, Inc. acquired SharperAgent, LLC for \$1.75 million in cash and approximately \$350,000 in assumed liabilities. Sharper Agent is a leading provider of online and print marketing suites with more than 30,000 real estate agent users across North America. For the year ended December 31, 2010, Sharper Agent had revenues of approximately \$3.5 million and positive cash flow from operations, based on Sharper Agent s unaudited financial statements for such period.
