**Item 2.02 Results of Operations and Financial Condition**

Equity LifeStyle Properties, Inc. (the Company) hereby reconfirms previously issued guidance for its net income per share (fully diluted) and funds from operations (FFO) per share (fully diluted) for the year ending December 31, 2012 to be \$0.89 and \$4.42, respectively. The projected 2012 per share amounts represent the mid-point of a range of possible outcomes and reflects management's best estimate of the most likely outcome.
