Mr. Singhal beneficially owns 2,086,091 shares of Common Stock. Mr. Singhal has sole voting and dispositive power over 1,753,991 shares of Common Stock.

Mrs. Singhal beneficially owns 915,676 shares of Common Stock. Mrs. Singhal has sole voting and dispositive power over 583,576 shares of Common Stock.

99,000 shares of Common Stock are held by a private foundation of which Mr. and Mrs. Singhal are trustees. 233,100 shares of Common Stock are held by a trust for which Mr. Singhal is one of two trustees. 233,100 shares of Common Stock are held by a trust for which Mrs. Singhal is one of two trustees.

Mr. and Mrs. Singhal are spouses. Mr. Singhal may be deemed to beneficially own the 915,676 shares of Common Stock beneficially owned by Mrs. Singhal. Mr. Singhal disclaims beneficial ownership of 816,676 of such shares. Mrs. Singhal may be deemed to beneficially own the 2,086,091 shares of Common Stock beneficially owned by Mr. Singhal. Mrs. Singhal disclaims beneficial ownership of 1,987,091 of such shares.
