**Item 7.01 Regulation FD Disclosure**

As previously disclosed, WellPoint, Inc. ( WellPoint ) was named as a defendant in *Mary E. Ormond, et. al. v. Anthem, Inc., et. al.* (the Ormond Litigation ), filed in the U.S. District Court for the Southern District of Indiana, asserting claims arising from the 2001 demutualization of Anthem Insurance Companies, Inc., and the initial public offering of common stock for its holding company, Anthem, Inc. (n/k/a WellPoint, Inc.). WellPoint expects to make an estimated non-tax deductible payment of approximately \$90 million in 2012 in connection with the resolution of this matter.

Taking into account the resolution of the Ormond Litigation, WellPoint is revising its earnings per share guidance for full year 2012 to be at least \$7.57 per share, including net investment gains of \$0.19 per share from the first quarter of 2012. This guidance includes no investment gains or losses beyond those recorded during the first quarter of 2012.

Officers of WellPoint expect to speak with securities analysts and investors during the period commencing on June 18, 2012, and ending on June 29, 2012. During these meetings, the officers expect to reaffirm this revised guidance.
