**Item 5.07 Submission of Matters to a Vote of Security Holders.**

Manitex International, Inc. held its Annual Meeting of Stockholders on June 5, 2014. The following is a summary of the matters voted on at that meeting.

- (a) **Proposal 1** The stockholders elected Manitex International, Inc.'s entire Board of Directors to serve until the 2015 Annual Meeting of the Stockholders. The persons elected to Manitex's Board of Directors and the number of shares cast for, the number of shares withheld, and broker non-votes, with respect to each of these persons, were as follows:
