#### Item 1.01. Entry into a Material Definitive Agreement.

On June 13, 2014, Mid-America Apartments, L.P. (the Operating Partnership ) issued and sold \$400 million in aggregate principal amount of its 3.750% Senior Notes due 2024 (the Notes ). The terms of the Notes are governed by an indenture, dated as of October 16, 2013 (the Base Indenture ), among the Operating Partnership, as issuer, Mid-America Apartment Communities, Inc. (the Company ), and U.S. Bank National Association, as trustee, as amended and supplemented by a second supplemental indenture, dated as of June 13, 2014 (the Supplemental Indenture ), among the Operating Partnership, as issuer, the Company and U.S. Bank National Association, as trustee.

The foregoing descriptions of the Notes, Base Indenture and Supplemental Indenture do not purport to be complete and are qualified in their entirety by the full text of the Base Indenture and Supplemental Indenture establishing the terms of the Notes, which are being filed as Exhibit 4.1 and Exhibit 4.2, respectively, to this Current Report on Form 8-K and are incorporated herein by reference.
