On November 6, 2014, Western Digital Corporation, a Delaware corporation, issued a press release announcing the pricing of the previously announced offering of 5,434,783 shares of its common stock by Hitachi, Ltd. (the Selling Stockholder ), at a price to the public of \$96.00 per share. The Selling Stockholder has granted the underwriters of the offering an option to purchase up to an additional 815,217 shares.
