Integration Planning Continues at Recent Summit

Leaders from both Medtronic and Covidien came together in mid-December to further the integration planning effort at the recent IMO (Integration Management Office) Summit in Minneapolis. While prior Summits had primarily focused on building integration plans and identifying interdependencies, the focus of the December Summit was about pressure-testing the plans and finalizing elements for post-closing execution.

The three-day Summit opened with detailed updates from the Regions and Businesses where critical Day 1-100 plan priorities, milestones and risks were shared and discussed. Attendees also heard detailed updates from a number of functional areas including Legal, Operations, HR and Communications.

Another key element of the December Summit was the interactive work sessions focused on a variety of post-close stakeholder scenarios. In advance of the Summit, various workstream leaders were presented with potential scenarios to test their plans and readiness for Day 1 of Medtronic plc. Scenarios covered everything from product ordering to management reporting to policies, and the workstream leads presented their proposed solutions to Summit attendees. These interactive sessions surfaced questions and potential gaps to be addressed as preparations continue for post-closing integration.

The balance of the Summit was allotted for the Regions, Businesses and Functions to meet in focused, cross-team working sessions to further refine and build out details for plans.

With no additional Summits planned prior to closing of the proposed acquisition, integration teams will continue to refine Day 1-100 plans and finalize preparations for post-closing execution. The IMO will also begin its transition to focus on execution with the establishment of a Command Center in January where preparations, task completion and issues related to integration plans will be centrally tracked.
