**ChipMOS SHANGHAI SECURES US\$33 MILLION CREDIT FACILITY**

**Hsinchu, Taiwan, July 12, 2016** - ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (Nasdaq: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ( OSAT ), today announced that through its majority-owned subsidiary ChipMOS TECHNOLOGIES INC. (TWSE: 8150), ChipMOS TECHNOLOGIES (SHANGHAI) LTD. ( ChipMOS Shanghai ), has secured a new US\$33 million, three-year, floating rate, secured, non-revolving credit line. Bank of Taiwan acted as lead manager of the syndicate, which also included Land Bank of Taiwan.

ChipMOS Shanghai expects to use the proceeds from the credit facility to further buildout its assembly and test capacity for LCD drivers and to provide additional working capital for general corporate purposes.

Mr. S.J. Cheng, Chairman and Chief Executive Officer of ChipMOS, and representatives from the bank syndicate were present at the signing ceremony held in office of Bank of Taiwan in Shanghai, China.

S.J. Cheng, Chairman and Chief Executive Officer of ChipMOS, said, We appreciate the continued excellent partnership of Taiwan's most prominent banking institutions in support of our growth plan. As in the past, we are strategically adding capacity in a conservative manner in order to best match anticipated customer demand requirements with our OSAT footprint. Our ongoing China expansion remains central to our longer-term success, and will help ensure our leadership position as the semiconductor industry supply chain continues to dynamically evolve at a rapid pace.
