- (1) On October 2, 2007, the common stock of Johnson Controls Inc., split 3-for-1, resulting in the reporting person's ownership of 27,350 additional shares.
Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination from the Board of Directors of the company and may be transferred by the reporting person into an alternative investment account or moved out of the plan.
- (2) The phantom stock units were accrued under the Johnson Controls Directors' Retirement Plan and are to be settled 100% in cash.
- (3) On October 2, 2007, the common stock of Johnson Controls Inc., split 3-for-1, resulting in the reporting person's ownership of 25,016.934 of additional phantom stock units.
- (4) Includes 482.986 phantom stock units acquired through the reinvestment of dividends on March 30, June 29 and October 2, 2007, and January 3, 2008, at prices ranging from \$31.54 to \$39.8667 per phantom stock unit.
