Golar LNG Limited ("Golar" or the "Company") announced today that it has completed its sale of interests in the companies that own and operate the LNG carrier *Golar Grand* to Golar LNG Partners L.P. ("Golar LNG Partners" or "the Partnership") for a price of \$265 million.

As consideration, the Partnership will assume a \$90 million finance lease liability (net of restricted cash) in respect of the Golar Grand and pay Golar the balance of \$175 million in cash.
