Novo Nordisk A/S – Share repurchase programme

On 9 August 2012 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.0 billion in the period from 9 August 2012 to 29 October 2012.

Since the announcement as of 10 September 2012, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 15,995,514 treasury shares, corresponding to 2.9% of the share capital. The total amount of shares in the company is 560,000,000 including treasury shares.
